**DECLARING AS THE SINGLE CALCULATED RESPONSIVE QUOTATION (SCRQ) AND
RECOMMENDING THE AWARD OF THE CONTRACT TO THE MYBUSYBEE INC. FOR
THE SUPPLY, DELIVERY, AND CONFIGURATION OF TOURISM PROMOTIONS BOARD
GOOGLE WORKSPACE LICENSE**

WHEREAS, there is an approved Purchase Request (PR) No. 6.012 with an Approved Budget for the Contract (ABC) of **Nine Hundred Fifteen Thousand Pesos (PhP915,000.00)**, for the Supply, Delivery, and Configuration of Tourism Promotions Board (TPB) Google Workspace Licenses;

WHEREAS, said item is included in the approved Project Procurement Management Plan of the Department and the Annual/Supplemental Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA9184);

WHEREAS, Section 53.9 of the RIRR of RA 9184 provides that *“the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex “H” of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR”*;

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR_2022.06.192) dated June 13, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on June 17, 2022 10:00 A.M.;

WHEREAS, on June 17, 2022, MYBUSYBEE INC. submitted its bid quotation before the set deadline;

WHEREAS, the Technical Evaluator for Alternative Methods of Procurement opened the submitted quotation on June 17, 2022, *with the following details*:




