**DECLARING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND  
RECOMMENDING THE AWARD OF THE CONTRACT TO ARTEMISPLUS EXPRESS INC. /  
KITCHEN CITY FOR CATERING SERVICES FOR WORLD FOOD EXPO – PHILIPPINE  
CULINARY CUP EVENT**

**WHEREAS**, there is an approved Purchase Request (PR) No. 7.010 with an Approved Budget for the Contract (ABC) of **Three Hundred Seventy-five Thousand Pesos (PhP375,000.00)**, for Catering Services for World Food Expo – Philippine Culinary Cup Event on August 3, 2022;

**WHEREAS**, said item is included in the approved Project Procurement Management Plan of the Department and the Annual/Supplemental Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

**WHEREAS**, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS**, Section 53.9 of the RIRR of RA 9184 provides that *“the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex “H” of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR”*;

**WHEREAS**, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR\_2022.07.229) dated July 14, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on July 20, 2022;

**WHEREAS**, on June 14, 2022, TJIOE The Caterer Inc. submitted its bid quotation;

**WHEREAS**, on July 19, 2022, Artemisplus Express Inc./Kitchen City and Super Ice, Inc./Creamery Catering submitted their bid quotations;

**WHEREAS**, the Technical Evaluator for Alternative Methods of Procurement opened the submitted quotations on July 20, 2022, *with the following details*:
