



## BIDS AND AWARDS COMMITTEE RESOLUTION NO. 2022-209

DECLARING AS THE SINGLE CALCULATED RESPONSIVE QUOTATION (SCRQ) AND RECOMMENDING THE AWARD OF THE CONTRACT TO RBHC COURIER SERVICE FOR THE SHIPMENT OF PROMOTIONAL MATERIALS AND CORPORATE GIVEAWAYS TO PHILIPPINE DEPARTMENT OF TOURISM OFFICE TOKYO, JAPAN

WHEREAS, there is an approved Purchase Request (PR) No. 7.045 with an Approved Budget for the Contract (ABC) of Three Hundred Thousand Pesos (PhP300,000.00), for the Shipment of Promotional Materials and Corporate Giveaways to Philippine Department of Tourism office Tokyo, Japan in connection with Tourism Expo Japan (TEJ) 2022;

**WHEREAS**, said item is included in the approved Project Procurement Management Plan of the Department and the Annual/Supplemental Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS,** Section 53.9 of the RIRR of RA 9184 provides that "the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR";

**WHEREAS**, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR\_2022.07.238) dated July 25, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on July 29, 2022;

WHEREAS, on July 28, 2022, EMR Courier Services International Inc. submitted their bid quotation;

**WHEREAS,** on July 29, 2022, RBHC Courier Service submitted their bid quotation before the set deadline of submission;

**WHEREAS,** the Technical Evaluator for Alternative Methods of Procurement opened the submitted quotations on July 29, 2022, with the following details:
