**RECOMMENDING SINGLE RATED RESPONSIVE BID (SRRB) AND TO AWARD THE
CONTRACT TO QE DESTINATION MARKETING SDN BHN FOR THE SERVICES OF A
MARKETING COMPANY TO PROVIDE TPB PHL MARKETING COORDINATOR FOR
MALAYSIA**

WHEREAS, there is an approved Purchase Request (PR) No. 5.027 with an Approved Budget for the Contract (ABC) of **Two Million One Hundred Twenty-five Thousand Pesos (Php2,125,000.00)** Lot 1, for the procurement of the **Services of Marketing Company to Provide Tourism Promotions Board (TPB) Philippines Marketing Coordinator for Malaysia**;

WHEREAS, the TPB PHL has facilitated the procurement of the Services of Marketing Agency to Provide TPB PHL Marketing Coordinator for Malaysia;

WHEREAS, on July 15, 2022 the Chief Operating Officer (COO) of TPB PHL approved the Bids and Awards Committee Resolution No. 2022-192, declaring **QE Destination Marketing Sdn Bhn** Eligible and Shortlisted to bid for the said project;

WHEREAS, on August 15, 2022, BAC Resolution No. 2022-226, Recommending the bid of QE Destination Marketing Sdn Bhn as a Single Rated Bid, to Conduct Negotiation, and Post Qualification, was approved by the COO of the TPB PHL;

WHEREAS, on August 23, 2022, Negotiation was conducted, the results of the Negotiation as agree is:

- For the new contract, the Marketing Coordinator may request partial reimbursement of the project expenses (before the full completion and implementation of the project) provided that the reimbursement request arrangement is indicated on the submitted proposal/complete staff work and presented based on the completion of the milestone, subject to the approval of the COO/Head of the Procuring Entity.

WHEREAS, upon careful examination, validation, and verification of the eligibility, technical, and financial documents presented during the post-qualification on August 23, 2022, the Technical Working Group (TWG) for Consulting reported that the bid of QE Tourism Destination Marketing Sdn Bhn is **Responsive**;

NOW, THEREFORE, FOR AND IN CONSIDERATION OF THE FOREGOING, We the Members of the Bids and Awards Committee, hereby **RESOLVE** as it hereby **RESOLVED** to recommend for **APPROVAL** of the Officer-In-Charge of the TPB PHL the following:

a. To **DECLARE** the QE Destination Marketing Sdn Bhn's bid for the Services of Marketing Company to Provide TPB PHL Marketing Coordinator for Malaysia as the **Single Rated Responsive Bid (SRRB)**; and

b. To **AWARD** the **CONTRACT** for the Services of Marketing Company to Provide TPB PHL Marketing Coordinator for Malaysia to QE Destination Marketing Sdn Bhn in the amount of **Two Million One Hundred Twenty-five Thousand Pesos (Php2,125,000.00)**, inclusive of all applicable taxes;


