



REQUEST FOR EXPRESSION OF INTEREST (REI No. 2022-009)

Services of a Marketing Agency to Provide a Tourism Promotions Board Marketing Coordinator for Malaysia and Singapore

1. The *Tourism Promotions Board (TPB)*, through the Corporate Budget FY 2022, intends to apply the sum of **Three Million Three Hundred Twenty-five Thousand Pesos** (**Php3,325,000.00**), inclusive of all applicable taxes, being the Approved Budget for the Contract (ABC) to payments under the contract for the *Services of a Marketing Agency to provide a TPB Marketing Coordinator for Malaysia and Singapore*. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposal.

Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

- 4. A complete set of Bidding Documents may be acquired by interested Bidders on July 4 to July 27, 2022 9:30 A.M. from TPB Office and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the TPB, provided that Bidders shall pay the applicable fee for the Bidding Document not later that the submission of their bids.

The cost of bidding documents shall correspond to the ABC range as indicated in the table below. This shall be the maximum amount of fee that procuring entities can set for the acquisition of bidding documents.

The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provision of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of five (5) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

6. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

Bidding is open to all interested bidders, subject to the conditions for eligibility provided in the IRR of $R.A\ 9184$

- 7. The **TPB** shall evaluate bid using the **Quality-Cost Based Evaluation/Selection** (**QCBE/QCBS**) procedure. The Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposals. The criteria and rating system for the evaluation on bids shall be provided in the Instructions to Bidders.
