**DECLARING AS THE SINGLE CALCULATED RESPONSIVE QUOTATION (SCRQ) AND  
RECOMMENDING THE AWARD OF CONTRACT TO MITNSIDE ENTERPRISES FOR  
PRINTING, SUPPLY AND DELIVERY OF TPB 2023 DESK CALENDARS**

**WHEREAS**, there is an approved Purchase Request (PR) No. 8.019 with an Approved Budget for the Contract (ABC) of **One Million Pesos (PhP1,000,000.00)**, for printing, supply, and delivery of TPB 2023 Desk Calendars;

**WHEREAS**, said item is included in the approved Project Procurement Management Plan of the Department and the Annual/Supplemental Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

**WHEREAS**, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

**WHEREAS**, Section 53.9 of the RIRR of RA 9184 provides that *"the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR"*;

**WHEREAS**, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR\_2022.08.261) dated August 15, 2022 on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on August 19, 2022 12:00 Noon;

**WHEREAS**, on August 17, 2022, VJ Graphic Arts, Inc. and Mitnside Enterprises submitted their bid quotations;

**WHEREAS**, the Technical Evaluator for Alternative Methods of Procurement opened the submitted quotations on August 19, 2022, *with the following details*:


