

**BIDS AND AWARDS COMMITTEE
RESOLUTION NO. 2022-257**

**DECLARING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND
RECOMMENDING THE AWARD OF THE CONTRACT TO EUODOO TECHNOLOGIES INC.
FOR HOSTING SERVICE OF THE TRAVEL PHILIPPINE'S MOBILE APP**

WHEREAS, there is an approved Purchase Request (PR) No. **8.042** with an Approved Budget for the Contract (ABC) of **Seven Hundred Thousand Pesos (Php700,000.00)**, for the **Procurement of Hosting Service for the Travel Philippine's Mobile App**;

WHEREAS, said item is included in the approved Project Procurement Management Plan of the Department and the Annual/Supplemental Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA9184);

WHEREAS, Section 53.9 of the RIRR of RA 9184 provides that *"the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR"*;

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (**TPB-PR_2022.08.272**) dated **August 23, 2022** on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on **August 30, 2022 12:00 P.M.**;

WHEREAS, on **August 30, 2022**, **Euodoo Technologies, Inc. and Mybusybee Inc.** submitted their bid quotations before the set deadline of submission;

WHEREAS, the Technical Evaluator for Alternative Methods of Procurement opened the submitted quotations on **August 30, 2022**, *with the following details*:


