**DECLARING AS THE SINGLE CALCULATED RESPONSIVE QUOTATION (SCRQ) AND
RECOMMENDING THE AWARD OF THE CONTRACT TO NICATTO EVENTS AND
MARKETING DYNAMICS CORPORATION FOR THE SERVICES OF EVENT
MANAGEMENT COMPANY FOR ASIA CASH CYCLE SEMINAR**

WHEREAS, there is an approved Purchase Request (PR) No. **7.058** with an Approved Budget for the Contract (ABC) of **Three Hundred Fifty Thousand Pesos (Php350,000.00)**, for the **Services of Event Management Company for Asia Cash Cycle Seminar**;

WHEREAS, said item is included in the approved Project Procurement Management Plan of the Department and the Annual/Supplemental Procurement Plan of the Tourism Promotions Board for Fiscal Year 2022;

WHEREAS, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement set forth in Rule XVI of the Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 (RA 9184);

WHEREAS, Section 53.9 of the RIRR of RA 9184 provides that *"the procuring entity may enter into negotiated procurement through Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the RIRR, provided that in case of Goods, the Procurement does not fall under Shopping in Section 52 of the RIRR"*;

WHEREAS, the Bids and Awards Committee (BAC) Secretariat posted the Request for Quotation (TPB-PR_2022.08.249) dated **August 3, 2022** on the PhilGEPS and TPB Websites with a *deadline* of submission of bids on **August 10, 2022 12:00 P.M.**;

WHEREAS, on **August 10, 2022**, **Nicatto Events and Marketing Dynamics Corporation** submitted its bid quotations before the set deadline of submission;

WHEREAS, the Technical Evaluator for Alternative Methods of Procurement opened the submitted quotations on **August 10, 2022**, *with the following details*:
