#### I.BACKGROUND

The Philippine Motorcycle Tourism is a fast-growing niche market in the Philippines, whose numbers are increasing up to the present. Significant islands in our country are being explored by motorcycle – the unspoiled landscapes, beautiful and serene coasts, green forest wildlife, and natural splendors. This is a marginal practice with special habits where taking the road, riding styles, and camaraderie play essential roles. This motorcycle tourism is an excellent example of the unusual and marginal nature of this tourism.

Capitalizing on the tourism potential, the TPB Philippine Motorcycle Tourism Program collaborated and partnered with the Department of Tourism (DOT) and various motorcycle rider clubs and associations in the Philippines.

Holding this kind of event will offer a good promotional value not just in the tourism destinations but also can help generate revenue for business and service providers in the locality. Participants will increase spending on which will be spent on transportation, gasoline, lodging, restaurants, entertainment, and shopping, thus contributing to increasing the sales in the tourism business industry. While traveling, adapting measures on health and safety protocols to fight against COVID19 will be strictly observed on the part of organizers, participants, and service providers



1. The **THUNDERBUGS BACOLOD MOTORCYCLE CLUB** (organized in 1964) will be hosting the annual gathering of motorcycle riders from all over the country in Bacolod City on 15 October 2022, in time for the Bacolod Masskara Festival 2022.

The "Masskara and Unity Ride 2022" has been an annual event since 2008 but was put on hold for the last two years due to the pandemic. It has been an important boost to the local tourism in Bacolod City and the Philippine Motorcycle Tourism (PMT).

2. The highly-anticipated flagship event of NORMINRING Motorbikes (NDC), the Mindanao Freedom Ride 2022 (#MFR2022), will be held on November 5 - 16 this year. Now on its eleventh (11<sup>th</sup>) running year, this group ride aims to navigate the Northern Mindanao, Western VIsayas, Luzon, South rhough Eastern Visayas, finally back to Mindanao. The exciting route, covering a distance in excess of 4,000 kilometers, will jump-off from Cagayan de Oro City and pass through various provinces.
