<b>23.</b>	Provision of hygiene kit to include at least a small bottle of alcohol, K95 masks throughout the trip, face shield (should it be required), wet wipes, tissue, vitamin C, sunscreen, mosquito repellant lotion	
<b>24.</b>	First Aid Kit during tours and on vehicles (land/water transfer) with basic medicines (antacid for upset stomach, headache, antihistamine for allergies, diarrhea, motion sickness, etc.) and antigen kits	
<b>25.</b>	In case of rain, provision of raincoats and golf umbrellas
