

TECHNICAL SPECIFICATIONS

SERVICES OF A TOUR OPERATOR FOR THE VESPA CLUB OF THE PHILIPPINES (VCOP) - TPB PHILIPPINE MOTORCYCLE TOURISM (PMT) PARTNERSHIP

I. BACKGROUND

In line with the thrust of the Tourism Promotions Board in the promotion of motorcycle tourism, the Vespa Club of the Philippines (VCOP) embarked on a collaborative endeavor to conduct a Vespa Day activity and conference among all Vespa riders and enthusiasts. This is an open ride activity where non-aligned Vespa riders/enthusiasts are invited in a “meet and greet” format in order to introduce and open up the Vespa Club of the Philippines (VCOP) National Federation to everyone.

Furthermore, this event serves as a litmus test for the Philippines to demonstrate its capacity to host a potential world activity like the Vespa World Day organized by the Vespa World Club where VCOP is a recognized Vespa club representing the Philippines.

For the 1st Quarter of 2023, there will be (three) 3 themed VCOP Rides (Ride and Dive – Batangas , Ride and Dine – Vigan, Ilocos, and Ride and Climb – Cordillera), and a day ride that will be the template for the National Vespa Rally.

The Tourism Promotions Board (TPB) Philippines needs the services of a tour operator for the VESPA CLUB OF THE PHILIPPINES (VCOP) THEMED POCKET RIDES 2023.

II. OBJECTIVES

This joint undertaking aims to achieve the following objectives:

a) To organize a Vespa riders/owners convention similar to the Vespa World Day format and determine its ability to organize and support this convention.

b) To organize a group ride to three (3) identified motorcycle tourism destinations on the first day to showcase the beauty under the three themed rides formatted as follows:
RIDE and DIVE, RIDE and CLIMB and RIDE and DINE themes.

III. SCOPE OF WORKS AND SERVICES

HOSTED DINNER WITH ENTERTAINMENT

a. To provide Hosted Dinner and Entertainment for Ninety (90) pax during the VCOP Themed Rides on the following destinations:

a.1 Anilao, Batangas (30 pax)

a.2 Baguio/Banaue (30 pax)

a.3 Vigan, Ilocos Sur (30 pax)

a. At least a maximum of Php 3,000.00 per pax

IV. PROJECT IMPLEMENTATION SCHEDULE

1st Quarter or 2023

V. ADDITIONAL TECHNICAL ELIGIBILITY REQUIREMENTS

- Must be a DOT Accredited tour operator/travel agency
- Bidder must submit a list of completed projects at least three (3) projects hosting similar projects/services.

VI. APPROVED BUDGET FOR THE CONTRACT (ABC)

The total ABC is **Three Hundred Thousand Pesos (PhP300,000.00)** inclusive of all applicable taxes and fee.

VII. TERMS OF PAYMENT

Payment will be on send-bill arrangement. Full payment upon completion of the requirements stipulated in the technical specifications thirty (30) days upon receipt of the Statement of Account (SOA)/Billing.

VIII. CONTRACT DURATION

The requirement is a one-time engagement and shall commence from acceptance of the Notice to Proceed (NTP).
