



REQUEST FOR EXPRESSION OF INTEREST (REI) No. 2023-008

CONSULTING SERVICES TO DEVELOP AND IMPLEMENT THE MARKETING PROGRAMS OF THE TOURISM PROMOTIONS BOARD: LOT 2 - MARKETING CONSULTANT FOR SINGAPORE

- 1. The Tourism Promotions Board, through the 2023 Approved Corporate Operating Budget intends to apply the sum of Three Million Five Hundred Twenty-Six Thousand Pesos Only (PhP3,526,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Consulting Services to Develop and Implement the Marketing Programs of the Tourism Promotions Board: Lot 2 Marketing Consultant for Singapore /REI 2023-008. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
- 2. The Tourism Promotions Board now calls for the submission of eligibility documents for Consulting Services to Develop and Implement the Marketing Programs of the Tourism Promotions Board: Lot 2 Marketing Consultant for Singapore. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before 31 May 2023, 1:30 PM at BAC Secretariat, Procurement and General Services Division, 4/F Legaspi Towers 300, Roxas Boulevard, Manila. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

The main envelope of the eligibility document shall be labelled as follows:

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Payments denominated in foreign currencies shall be converted to Philippine currency based on the exchange rate as published in the Bangko Sentral ng Pilipinas (Central Bank of the Philippines) reference rate bulletin on the day the payment was made.

5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of **five (5) prospective bidders** who will be entitled to submit bids. The criteria and rating system for short listing for Lot 1: Marketing Consultant for Malaysia and Lot 2: Marketing Consultant for Singapore are:

The passing score to be shortlisted is 80%

- 6. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.
 - Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
- 7. The Procuring Entity shall evaluate bids using the *Quality-Cost Based Evaluation/Selection* (*QCBE/QCBS*). The Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.

- 8. The contract for Lot 2: Marketing Consultant for Singapore shall commence from the date of the Consultant's receipt of the Notice to Proceed until the completion of the deliverables identified in the final payment.
- The *Tourism Promotions Board* reserves the right to reject any and all bids, declare a failure
 of bidding, or not award the contract at any time prior to contract award in accordance with
 Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder
 or bidders.
